RELEASE AND WAIVER

WHEREAS, the undersigned releaser wants to fly, and otherwise operate a certain motorized aircraft (the "aircraft"), sometimes called a "recreational vehicle," or ultralight, and otherwise participate in activities sponsored by the "Wild West Ultralight Association" hereafter called such activities, such flying and other operation of the aircraft and other participation is sometimes hereinafter referred to as "participation" or "participate"; and

WHEREAS, in order to be permitted to participate in such activities, the undersigned releaser takes upon himself/herself, and releases all others from, the full responsibility for any and all injuries, losses and damages which may occur to or be inflicted upon himself/herself or his/her property, or the property or person of any other individual or entity, including any member(s) of his/her party; and

WHEREAS, the undersigned releaser fully understands that his/her participation in such activities is permitted only because of his/her representations set forth in this document and because of his/her willingness to waive and release the claim's and rights mentioned in this document

THEREFORE, in consideration of the permission granted to him/her to fly and otherwise operate such aircraft and otherwise participate in such activities, the undersigned releaser unconditionally agrees as follows:

He/she hereby waives and releases any and all claims, rights and/or causes of action which he/she now has or may have against the United States Ultralight Association, Inc., Wild West Ultralight Association, any organizers of such activities, and any landowner or business proprietor whose property, facilities, or services are used with regard to any and all injuries, losses or damages which may occur to or be inflicted upon himself/herself or his/her property, or any member(s) of his/her party or their property, which relate to, or which may in any way arise out of (a) any suggestions provided to him/her whether successful or not, to fly or otherwise operate the aircraft, (b) any suggestions provided to him/her concerning such activities, and (c) any other participation by him/her or any member of his/her party in such activities.

He/she hereby indemnifies and holds harmless those persons and entities listed above from any and all damages to the person or property of any individual or entity which arise out of his/her operation or attempted operation of the aircraft or other participation in such activities.

He/she represents that he/she is familiar with the characteristics and operation of the aircraft and is legally qualified to fly the aircraft.

He/she represents that he/she is in good physical condition and is physically able to operate the aircraft.

He/she represents that the aircraft is in good mechanical condition.

He/she acknowledges that he/she is fully aware that flight involves travel in three dimensions, and that such activity is subject to mishap, injury or possibly even death.

He/she acknowledges that no warranties, either expressed or implied, have been given him/her concerning the safety of participation in such activities, and safety of the flight, or the fitness of the aircraft, or the fitness of any proposed landing sight including and that he/she is undertaking to participate in such activities and to operate the aircraft solely at his/her own risk.

He/she is over eighteen (18) years of age or, if under eighteen (18) years of age, has permission form his/her parent or legal guardian to participate in such activities.

He /she acknowledges photographic, video, and other visual portrayals of Member in any pictorial medium of any nature whatsoever for the purpose of trade, advertising, sales, publicity or otherwise, without compensation to Member, and all rights, title and interest therein shall be photographer's sole property, free from any claims by member or any other person deriving rights or interest from Member.

If married, he/she has executed this document on behalf of himself/herself, his/her wife/husband and the marital community which they comprise. He/she also executes this document on behalf of all members of his/her party.

The contents of this document shall be forever binding upon the releaser, his/her dependents, heirs, personal representatives, and estate.

He/she has read this entire document, understands its contents and knows of the truthfulness thereof.
